

## **DECLARATION OF LEGAL LIABILITY IN CASE OF INJURY**

I also declare, that I will perform the fair-play activity. With my signature I also give up all the rights on any copyright on audiovisual recordings and photos made on the Site in order to promote it in the future. My participation in the area is voluntary.

By signing this document I also confirm that I am over 18 years of age, I have no illness, I have not suffered from any trauma and I have not any mental illness or other disorder that could in some way limit my ability to perform sport in the area.
