

GENERAL BINDING TERMS OF SPORTS CLUB MEMBERSHIP

These General Conditions of Membership in the Sports Club govern the rights and obligations of membership in the HANGAIR Sports Club (hereinafter referred to as the "**Sports Club**"), which was established and exists at the civic association Sports Club HANGAIR, o. z., with the address Pri Starom letisku 10851/3B, 831 07 Bratislava - municipality of Vajnory, Republic of Slovakia, ICO: 35539895 (hereinafter referred to as "Civic Association").

1 ESTABLISHMENT AND TERMINATION OF MEMBERSHIP

- 1.1 Membership in the Sports Club is established by properly filling out the Application for a Sports Club Member and its acceptance by the Sports Club. The Sports Club is not obliged to accept every application as a member of the Sports Club, and the Sports Club is not obliged to justify its decision.
- 1.2 For reasons of legal certainty, it is expressly stated that upon becoming a member of the Sports Club, a member of the Sports Club does not become a member of the Civic Association itself, nor does it acquire any voting or other rights in the Civic Association.
- 1.3 Membership in the Sports Club is voluntary and ends when a member withdraws from the Sports Club unilaterally or when the membership is terminated by the Sports Club. Termination of membership in the Sports Club is immediate in both cases. Withdrawal or termination of membership can be done in person, verbally, or by other suitable means (e-mail).
- 1.4 The applicant is responsible for the complete and truthful information in the application.

2 PURPOSES OF MEMBERSHIP

- 2.1 The purpose of membership in the Sports Club is to create suitable conditions for performing sports, organizing competitions, and the preparation and participation of members or teams consisting of members in competitions.
- 2.2 The Member of the Sports Club participates in the competition under the name of the Sports Club only upon agreement with the Sports Club and its participation is not mandatory.



3 MEMBERSHIP AND TRAINING COSTS

- 3.1 The member is not obliged to pay any regular membership fees for membership in the Sports Club.
- 3.2 The member is obliged, unless otherwise expressly agreed with the Sports Club, to reimburse the Sports Club for the member's ordered training according to the current price list at www.hangair.sk/sportovyklub.
- 3.3 All members of the Sports Club are subject to the rules published in the document Rules of Hangair courses binding for members of the Hangair Sports Club o.z., which are published on the website www.hangair.sk/sportovyklub.

4 FINAL PROVISIONS

- 4.1 These General Terms and Conditions of the Sports Club are valid from 01.07.2022, and information on familiarization with and agreeing with them is an integral part of the binding registration as a member of the Sports Club.
- 4.2 An integral part of these General Terms and Conditions of the Sports Club are also the General Terms and Conditions and the Operating Rules of Hangair s. r. o. as the operator of the sports ground in which the Sports Club carries out its activities. Each member of the Sports Club is obliged to accept these rules and follow them when moving around the sports field.
- 4.3 Sports club and company Hangair s. r. o. processes the personal data of a member of the Sports Club, and all information about the method of this processing can be found in the document Rules for the Protection of Personal Data of the company Hangair s. r. o., which are applied to membership in the Sports Club by analogy.
